Benjamin “Sam” S. Engram, Jr., 75, died Wednesday December 6, 2017 at his residence. A memorial service will be held Saturday, December 9, 2017 at 2:30 PM at St. Paul’s Episcopal Church. Rev. Lee Lowery will officiate.

Sam graduated from law school from the University of Tennessee at Knoxville. He returned to Albany after law school where he would practice law for 50 years. Early in his career, he served as the interim District Attorney of Dougherty County. He spent most of his career in private practice. He loved being an attorney and helping others.

Sam was a long-time member of St. Paul’s Episcopal Church in Albany, GA where he served on the vestry. He loved the outdoors, especially canoeing and camping with his family and friends.

Survivors include his son Benjamin S. Engram, III, his daughter Elizabeth Anne Engram, his son Franklin Edward Engram, and his sister Gini Martin. He was a proud grandfather to his three grandchildren: Thayer Dann Hall V, Barnes Leigh Anne Hall, and Madison Elizabeth Hall.
