



## Carl F. Laubrich Obituary

Carl "Chuck" Friedrich Laubrich, Jr., 48, of Albany, died Saturday, March 4, 2006 at his residence. The funeral service will be held at 2 PM Tuesday at Living Waters Christian Fellowship with Pastor Mark Knight officiating.
