



## Charles W. Hill Obituary

January 31, 1930 - October 8, 2006

Mr. Charles William Hill, 76, died Sunday October 8, 2006 at his residence. Funeral services will be held at 11:00 AM Wednesday at Kimbrell-Stern Memorial Chapel with burial to follow at 5:00 PM in Kite, Georgia. Revs Butch Knight, Ed Thompson and Burton Dixon officiating. Visitation with the family will be Tuesday at Kimbrell-Stern from 5:00 until 7:00. Mr. Hill was the son of the late Charles Colson (CC) Hill and Elizabeth Brooks Hill and was a native of Albany, graduating from Albany High School in 1947. He was on active duty in the United States Air Force from 1948 through 1949 and was honorably discharged from his reserve unit in August 1956. Mr. Hill received his bachelor's degree from Mercer University and continued his education at Walter F. George School of Law where he received his Juris Doctor in 1956. After law school Mr. Hill returned to Albany where he practiced law for thirty years before retiring. He was a member of the American Bar Association, Georgia Bar Association and the Dougherty County Bar Association. He was also a member of Sigma Nu Fraternity and Phi Alpha Delta Law Fraternity. Mr. Hill was a member of Albany First Baptist Church for 69 years. He was also a member of the Elks Lodge and Flint Skeet and Trap Club. Mr. Hill was an avid sportsman and played baseball for Mercer. He continued his interests in sports and became a nationally recognized skeet shooter. Mr. Hill was named to nine All-American teams, 13 All-State teams and was enshrined in the National Skeet Shooting Association Hall of Fame in 1991 and the Georgia Skeet Shooting Hall of Fame in 1994. He is survived by his wife of 55 years,

Martha Claxton Hill, two daughters, DeAlvah Hill Simms (Howard), and Charlene Hill Craig (Sandy), and grandchildren Elizabeth Grace Simms, Howard Zachary Simms, Jr., Charles Colson Craig and Clayton Claxton Craig.
