



## Curtis L. Faircloth Obituary

Mr. Curtis L. Faircloth 65 of 3402 Radium Springs Rd., in Albany died April 28, 2006 at his residence. A native of Miami, FL, Mr. Faircloth has lived in Albany since 1940 where he was a member of Harvest Temple Church of God. Mr. Faircloth was the owner of Faircloth Bonding Co. and was a member of the Albany Civitan Club for over 35 years where he served as past Governor of the South Georgia District of Civitan International, and served numerous years as chairman for Junior Civitan South Georgia district. Mr. Faircloth received numerous honors and awards, and was a high honor recipient of the International Fellow in his name. He was chairman and co-founder of the Camp Civitan a camp that he was deeply passionate about for physically and mentally challenged children at Kolomoki Mounds State Park. Mr. Faircloth was a 1959 graduate of Albany High School, where he played baseball on the Albany High Indians baseball team and received a full scholarship to the University of Maryland. Survivors include his wife, Bobbie Faircloth of Albany, son, Lavon Faircloth of Albany, daughter, Janet Woodward of Albany, two grandchildren, Ricky and Kayla Faircloth of Albany and two great-grandchildren, Destiny and Hartwell Faircloth of Albany, two brothers, Kenneth Faircloth of Albany and Adger Best of McRae, GA Mr. Faircloth was preceded in death by his wife, Ann Faircloth who died in 1997.
