D. Lamar "Bubba" Stewart, Jr., 70, of Albany, died Sunday, December 18, 2005 at his residence. A native of Baconton, Mr. Stewart had lived in Albany most of his life. He graduated from Albany High School in 1953. After high school, Mr. Stewart joined the U.S. Army and served for a while in Germany. He was a graduate of the University of Georgia and the Woodrow Wilson Law School in Atlanta. Mr. Stewart was an agent with the F.B.I. in Newark, NJ. He moved back to Albany where he practiced law for a number of years, and then went on to serve as a Municipal Court Judge for a number of years. Mr. Stewart was preceded in death by his son, Harvey Lamar "Rusty" Stewart; his wife, Marilyn R. Stewart; and his parents: D. Lamar Stewart, Sr. and Mary Lou Murphy. Mr. Stewart is survived by two daughters: Tamara Johnson and Tracey Neubert, both of Knoxville, TN; three grandchildren: Rusty Harpe, Danielle Stewart, and Stephanie Neubert; three step-daughters: Buffy Mobley of Cairo, Kelly Knight of Albany, and Missy Hayes of Newton; six step-grandchildren; three sisters, Jan Parker of Albany, Linda Zimmerman of Atlanta, and Judy Hughey of Dallas, TX; and several nieces and nephews.
