Mr. Danny Conyers, 70, died September 30, 2017. A funeral service will be held for Mr. Conyers on Tuesday, October 3, 2017 at 11 AM at Kimbrell-Stern. Rev. Charles Jones will be officiating. The family will receive friends for visitation on Monday, October 2, 2017 from 6-8 PM at Kimbrell-Stern.

Mr. Conyers was born March 15, 1947 in Bainbridge, GA, although he spent most of his life in Albany. He was a Graduate of Albany High School Class of 1967. He was a member of First Baptist Church in Dawson, GA where he also co-taught with his wife Sue Conyers the Fifth Grade Sunday School Class. He served on various committees and very involved with his church. He started his business, Conyers Grading and Landscaping in 1976, and today the business is known as Conyers Concrete and Asphalt Services Inc. Mr. Conyers was a veteran and served our country in the US Army Reserve. He was also a founding member of the Albany Bass Club.

Mr. Conyers is preceded in death by his parents, Frank and Louise Conyers. Mr. Conyers is survived by his wife, Sue Hines Conyers of Dawson; his children, Scott Conyers (Dean'Na) of Dawson, Josh Conyers (Melissa) of Lee County, and Haley Conyers Denney (Chad) of Lee County; his grandchildren, Logan Conyers, Libby Conyers, and Henley Denney. He is also survived by his brother, Todd Conyers (Dottie) of Dothan, AL.
