



Jesse W. Walters Obituary

December 5, 1919 - December 7, 2003

A native of Cuthbert, GA, Mr. Walters lived most of his life in Albany. He graduated from the University of Georgia and the University of Georgia Law School. During World War II, he served in the Army Air Corps as a P-51 pilot stationed in England. Mr. Walters was admitted to the bar in 1949, and began his legal career in Albany with the firm of Peacock, Perry, and Kelley, beginning a 50 year association with H. Holcombe Perry. He was associated with the firm of Perry and Walters at the time of his death. He served as Dougherty County Attorney from 1962-1979, and served as the Dougherty County School Board attorney for 35 years. In 1972, he was admitted as a fellow of the American College of Trial Lawyers. Mr. Walters was preceded in death by his wife: Lucy Yancey Walters, his sister: Leila Walters Murray, and his brother Arthur Walters.

The major thing I learned from J. (he said his name was not "Jay") was to never give up. Many times we would find ourselves in a bad situation that I was sure we could not get out of. But 99 times out of 100 J. would work out of it. He was a bull dog, go-for-the-jugular", give-no-quarter, shoot-from-the-hip type of fighter/lawyer. If he had been born 50 years earlier, he would have been a excellent gun fighter; if he had gotten to Europe before World War II was over, he would have been an ace fighter pilot. "Surrender" was not in his vocabulary.

As all other lawyers in our firm, I had many unpleasant times with J., but I knew he didn't mean anything personal in his contrariness and learned that he was simply doing everything possible for the benefit of our clients and no effort was too much - as long as it was honorable, honest and the right thing to do. As difficult it was to live with for the moment, I knew he was fighting for the good of the client, which made it bearable in the long run.

I miss J., but he will always be a part of me because of what he taught me. And I very much appreciate the opportunity to have been associated with him for so many years.

I will not be surprised if on Judgment Day J. is not standing before the Golden Throne arguing with Saint Peter and God on behalf of some poor soul trying to get through the Pearly Gates - maybe
