



## Robert Burch Langstaff Obituary

February 5, 1930 - February 16, 2010

Bob attended the University of Tennessee prior to entering military service in 1951. He went through Officer Candidate School and stayed as an instructor. While stationed in Fort Benning, he met and married Calista. Upon being honorably discharged, he enrolled in the University of Georgia Law School where he graduated cum laude and was initiated into the Gridiron Club. After law school, he joined the firm of Perry & Walters in Albany in 1956. He opened his own practice in 1972 forming Langstaff, Campbell, & Plowden. He later practiced law with all three of his sons eventually forming Langstaff Law Offices. During his legal career he argued before the U. S. Supreme Court, the 5th and 11th Circuit Court of Appeals, the District of Columbia Circuit Court of Appeals; and various federal and state courts in Georgia.
