



## Samuel Hammond, Jr. Obituary

September 27, 1937 - October 16, 2003

A native of Mitchell County, Mr. Hammond moved to Albany as a young adult where he graduated from Albany High School in 1957. After high school he joined the military and served as a hospital corpsman. He was stationed in San Diego, CA, Pensacola, FL, and Camp Lejune, NC. After being discharged in 1962, Mr. Hammond returned to Albany where he began work with the US Postal Service. In 1978, he was promoted to Postmaster of Edison, GA, where he stayed until his retirement in 1992. Upon his retirement from the Postal Service, he assisted his son Phil with their business, Albany Auto Trim. He was active in the Edison Lion's Club and served as its president for a year. He was preceded in death by his first wife of 36 years, Betty Jennings Hammond, his father Sam Hammond, Sr. and his mother, Curtis Godwin Hammond.
