



Mrs. Susan "Sunny" Caldwell Zeese Obituary

Susan "Sunny" Caldwell Zeese, 65, of Albany, died Wednesday, January 9, 2013 at Phoebe North Hospital.

Her funeral service will be Saturday, January 12, 2013 at 11 AM at St. Paul's Episcopal Church. The Rev. James Bullion, the Rev. Joy Davis, and the Rev. Jim Purks will officiate. Mrs. Zeese's remains will be cremated following the service, and her cremated remains will be buried in Royston, GA at a later date.

Mrs. Zeese was born in Royston, GA and she graduated from Franklin County High School in 1965. She received her undergraduate degree from the University of Georgia, and went to art school in Mexico City. Mrs. Zeese moved to Albany in 1972. She was a member of St. Paul's Episcopal Church and was a member of the Cursillo #105 Group.

“ *I remember Sonny all the way back to Law Dames at UGA in the early 1970's. She lived her life in full Technicolor, in stereo at full volume and with a unique personal style. She was never satisfied with anything less than each person's best efforts. We had our first children at the same time, and when Robert was in my Latin class, there was no doubt that he was the apple of her eye.*

She was unstintingly generous with her time even when receiving little if any public recognition. I remember her expertise in helping prepare Sarah Philips, Miss JCL, for the 1996 Miss Westover pageant. Sarah won.

I remember talking with Sonny about her own mother's death. It was a lesson for me in how to respond to the grieving in a more compassionate way, and helped me years later as I made peace with the deaths of my own parents.

If there are pageants or galas or grand occasions in Heaven, I'm sure Sonny is in charge or at the least, she's directing the backstage, applying make-up and giving pep-talks to all involved. She will be missed!
